Legislative Updates

U.S. House of Representatives' [Bill HR7](#) is referred to as the "No Taxpayer Funding for Abortion and Abortion Insurance Full Disclosure Act of 2023". It was sponsored by [Smith, Christopher H. \[Rep.-R-NJ-4\]](#) and introduced January 9, 2023. To date, Rep. Smith has found 168 Cosponsors. [All Actions](#) is a link to the Congressional website where the bill's activities can be followed.

All 168 cosponsors are Republicans. Representatives, John Curtis (UT), Jodey Arrington (TX), and Gregory Steube (FL) have recently joined the cosponsor list. Oregon Rep. Lori Chavez-DeRemer has not yet signed on as a co-sponsor to help expand true science-based health policies for women.

In September, a coalition of 75 pro-life organizations wrote a [letter to members of Congress](#) declaring their support for the success of *Dobbs v. Jackson Women's Health Organization* from the U.S. Supreme Court in 2022. 228 congressional members cosigned an [amicus brief](#) in support of the U.S. Supreme Court ruling. The coalition of organizations reminded Congress of the importance of continuing to work to protect life in legislation like creating at least a minimum standard age of gestation as we all work toward full protection of the unborn. [Deborah Tilden](#) through her business, [LifeVictory Enterprises, LLC](#), attached her name to this important coalition letter.

DEFUND PLANNED PARENTHOOD and DEPARTMENT OF EDUCATION!

Why do we need to DEFUND Planned Parenthood and the US Department of Education? They promote lifestyles that put children and women at risk, i.e., abortions and alternate sexual behavior. At a time when [Sound of Freedom](#) has just come out, the opposition hit pieces are pushing sexually deviant ideologies that target children and their innocence. DOJ Deletes Child Sex Trafficking from Website While Movie Reveals Evils of Open Border Policies

FL-13 U.S. Representative Anna Paulina Luna breaks the [news](#) that the Department of Justice has deleted their website content on International Child Sex Trafficking. From her office, “It has come to light that the Department of “Justice” has scrubbed key information from its webpage on child sex trafficking by deleting entire sections that previously highlighted the International Sex Trafficking of Minors, which has been brutally exacerbated by President Biden’s own policies.”

On May 12, 2023, the Biden Administration made substantive cuts to its website detailing the evils and causes of the global sex trade of children, erasing three sections: “International Sex Trafficking of Minors,” Domestic Sex Trafficking of Minors,” and “Child Victims of Prostitution.” “The DOJ specifically deleted a section that implicated the Biden Administration’s open-border policies in correlation to the sex trafficking of children. The deleted portion read, “One form of sex trafficking involves the cross-border transportation of children. In these situations, traffickers recruit and transfer children across international borders in order to sexually exploit them in another country.”

Approximately 85,000 children who have crossed the U.S. border under Biden’s watch are not accounted for. **Christie Hutcherson**, [Women Fighting For America](#), has exposed the hellish situation that these children are in including murder to harvest their organs.

The District of Columbia U.S. Court of Appeals, D.C. Circuit, has found 3-0 in favor of **Students For Life of America and for the Frederick Douglass Foundation**. Alliance Defending Freedom (ADF) represented the lawsuit to protect pro-life students’ right to free speech. The issue arose from these two organizations wanting to write a pro-life message on the sidewalk with chalk! Although the case will likely go to the Supreme Court, this is a major court win for free speech!

American College of OB/GYN(ACOG) Nationally Announces Support for Up to Birth Abortions, ‘No Limits’

From the website, [Susan B. Anthony Pro-Life America](#), “Washington, D.C. – [August 31, 2023]...top leaders of the American College of Obstetricians and Gynecologists (ACOG) and Society of Family Planning penned an op-ed in The Washington Post and called for honesty in the abortion debate. They called for abortion on demand, any time for any reason. They state that abortions “must be available without restrictions, without limitations and without barriers.”

Their op-ed was in response to **SBA Pro-Life America President Marjorie Dannenfelser** and strategist **Kellyanne Conway’s recent op-ed** in the Washington Post in which they lay out how Republican presidential candidates must go on offense and contrast their pro-life view with the extreme Democratic view of abortion on demand.” While both of these statements were from opinion pieces, they demonstrate the polarized positions that Americans may have. This schism makes for difficult politics. It certainly explains why some Republicans can not commit to cosponsoring US House Bill HR7 for fear of losing votes. So, mores have nothing to do with passing bills in the House of Representatives?

On September 14, 2023, Tucker Carlson interviewed **Javier Milei, a candidate for President of Argentina**, on X (formerly, Twitter.com), Episode 24. Argentina is a country whose politics have been lost to socialism. Milei warned Americans that socialism does not work and in fact, promotes population control and the breakdown of the family. On abortion, Milei asked, “How can a person decide who lives and who dies?” He plainly described abortion as murder, saying that this is “man against nature”. Milei is an Argentinian libertarian and stands a good chance to win their election.

Is open-ended abortion the true position of most Republicans? Independents? Democrats, even? Has there been polling to support ACOG’s point of view? Let’s hope that late-term abortions are offensive to most voters. In fact, the press release from SBA Pro-Life says most “practicing obstetricians will not perform an elective abortion.” Milei’s comments support Dannenfelser and Conway’s thesis. Unrestricted abortion aligns with the American Democratic plan which leans more and more socialist. No opposition to unrestricted abortion shows weakness on the Republican candidates’ part. Next year’s election cycle will reveal candidates’ approach to this.

Geneva Consensus Declaration

[Geneva Consensus Declaration](#), **promoting Women’s Health and Strengthening the Family**, is an international pro-women’s health declaration cosponsored by several countries around the world. This document supports strong women’s healthcare while rejecting the claim that abortion is an international human right. Signing on October 22, 2020, Secretary for Health and Human Services Alex Azar emphasized that “*The Geneva Consensus Declaration is an historic document stating clearly where we as nations stand on women’s health, the family, honoring life, and defending national sovereignty.*” “*The declaration is much more than a statement of beliefs.*” Newly installed President Biden removed the United States from the declaration on January 28, 2021. Valerie Huber as the President of the Institute for Women’s Health and an architect of the Geneva Consensus Declaration is working hard to bring the US back into the GCD. Opponents of Maine's New Abortion Law Won't Seek to Nullify it Through a Referendum

Maine's new abortion law, introduced by their Democratic Governor Janet Mills and passed on July 19, 2023 by their Democratic House of Representatives and Senate, leaves the decision to abort the fetus to the doctor and the patient. Mills feels that it made sense to remove the government from the decision-making. Republicans argued that it opened the door to any abortion at any time during pregnancy. Republican State Representative Rachel Henderson said, "That is a very narrow window, and yet we have a huge door that opens up the possibility for full-term, fully viable, healthy human beings to be terminated." Opponents of the law have decided "that the costs of collecting signatures and running a campaign represented too big of a hurdle. Instead, the groups intend to focus on electing candidates who are opposed to abortions." (from David Sharp, Associated Press) The cost was too high. This highlights the importance of supporting and voting strong life-affirming candidates into office.

Rasmussen and McLaughlin Polling

Check out the [Rasmussen](#) and [McLaughlin](#) Polling companies recently questioned voters on Pro-life issues. Here are some of their results.

MCLOUGHLIN GROUP:

Abortion is the #2 most important issue to voters, AND they trust REPUBLICANS more than Democrats regarding the abortion issue.

Recommended messaging:

1. We need to value life and promote a culture of life! Make LIFE cool again!
2. Science HELPS, but not the be all, end all! (yes, thank you, it's PART of the overall discussion narrative)
3. Sound reasonable and compassionate - politics is about winning minds and hearts!
4. Be aggressive about pointing out the EXTREMISM of the other side!
5. Start early, be consistent, don't let them define you, the left is going there!

RASMUSSEN:

73% of voters say there are TWO LIVES TO CONSIDER: both mother and child

75% among voters who identified as Black Democrats (10 points higher than white democrats)

63% of voters think it's important to protect a woman's right to choose, but that choice should be made EARLY IN PREGNANCY. (INFORMED CONSENT AND FULL DISCLOSURE IS A CRITICAL PIECE TO THE PUZZLE)

FDA Approval of Abortion Pills Revoked

[Vitae Foundation](#) reports the following, "After a daunting series of [lawsuits](#), appeals, and hearings, a decision has been made by the Fifth Circuit Court of Appeals for the Federal Drug Administration (FDA) to restore critical safeguards for Mifepristone. Mifepristone is the first of a two-drug chemical abortion regimen and is used in over 52% of abortions in America." This abortion method may not be sent through the mail putting the previous rulings back in place. However, the Supreme Court must uphold this decision. Abortion by mail has become a popular but even more tragic way for women to abort their babies. *Let's hope that the US Supreme Court will support this ruling.*
